**Explanation of Responses:**

- Represents the vesting of 25% of a grant issued on February 17, 2021 of restricted stock units, which were settled in PDM common stock.
- Each restricted stock unit represents a contingent right to receive one share of PDM common stock. Restricted stock units may be settled in cash or common stock at PDM's election.
- In connection with the vesting on February 17, 2022 reported above, 1,100 shares were forfeited by the employee and delivered to PDM to satisfy tax withholding obligations.
- Represents the vesting of 25% of a grant issued on February 19, 2020 of restricted stock units, which were settled in PDM common stock.
- In connection with the vesting on February 19, 2022 reported above, 552 shares were forfeited by the employee and delivered to PDM to satisfy tax withholding obligations.
- On February 17, 2021, the reporting person was granted 10,204 restricted stock units, vesting in four equal, annual installments beginning on the grant date.
- On February 19, 2020, the reporting person was granted 5,121 restricted stock units, vesting in four equal, annual installments beginning on the grant date.
